BRISTOL-PLYMOUTH REGIONAL TECHINICAL SCHOOL STUDENT PARKING RULES, REGULATIONS & APPLICATION

Parking is for available for Senior and Junior students only. Those students who park a vehicle on the school campus must submit an application for parking. Students are NOT allowed to park cars, motorcycles or motor scooters on school property unless they have been issued a valid parking permit from the Assistant Principal's office. If you were issued a parking permit from the previous year 2022-2023, please update your parking status in the office within 2 weeks from the start of the school year. You will be given a new parking permit for the current school year. If you are driving a vehicle to school temporarily or in any another vehicle other than the vehicle that the application was submitted for please alert the Assistant Principals' office so that a temporary pass can be recorded. You will need to obtain a temporary pass to park. You may not loan this temporary pass to another student.

Parking on the school campus is limited and will be monitored for vehicles that do not have a school issued parking permit. Parking permits are **REQUIRED** to be visible (handing from the rearview mirror with the permit number facing outward). Parking permits cannot be blocked, obstructed, covered or decorated. Students may not sell, duplicate/copy, transfer or loan their approved parking permit to other students. Students with a duplicate or fabricated parking permit will lose parking privileges for the rest of the school year and will not be allowed to reapply for a parking permit for the next school year.

Any student vehicles that does not display the visible will received a written warning. After the second warning, parking on the school campus will be revoked for 2 weeks.

Student parking is limited to the student parking lot only.

No parking in all spots surrounding the Childcare Building

Student parking is not allowed outside of trade shops

The display of offensive material, which could be considered as harassment or bullying is strictly prohibited on school grounds, this includes, but may not be limited to the display of symbols, Flags, graffiti, or other ornaments/ adornments.

Parking a vehicle on school property is a privilege, not a right. Please review all parking regulations with your parents and contact the office if you have further questions.

Student driven vehicles parked on campus are subject to search if there is reasonable suspicion to be believe they are housing drugs, weapons, alcohol, stolen property or other illegal items or contraband.

State and town citations take precedence over Bristol-Plymouth regulations.

Loitering in the parking lot is prohibited. Students should park their vehicles, gather all of your items for the day (notebooks, binders, library books, text books, shop uniforms, gym clothes, sneakers, lunch money, etc, etc.) lock their vehicles and exit parking area. YOU WILL NOT BE ALLOWED TO RETURN TO YOUR VEHICLE DURING THE DAY.

If you were involved in any kind of accident or fender bender (no matter how minor) this incident needs to be reported to the office or the SRO.

You must not occupy more than one parking spot. Your vehicle must be parked so that all spots around your vehicle are able to be accessed and utilized.

It is expected that you will be courteous of other drivers in the parking lot and yield to pedestrians. Do not drive around other drivers who are in line waiting to exit. Allow alternate merging of cars when exiting the school at both entrances. Improper or careless driving on the part of a student will result on a suspension or revocation no parking privileges and may include additional disciplinary actions.

Bristol-Plymouth is not responsible for damages or theft from vehicles. Students are cautioned NOT to leae valuable in their vehicles Parked vehicles should be left with the windows closed and doors unlocked.

The posted speed limit on school property is posted at 10mph.
